DETAIL SPECIFICATION

WIRE ROPE, FLEXIBLE, FOR AIRCRAFT CONTROL, GENERAL SPECIFICATION FOR

This specification is approved for use by all Departments and Agencies of the Department of Defense.

1. SCOPE

1.1 <u>Scope</u>. This specification covers the requirements for carbon steel and corrosion resistant steel aircraft control flexible wire rope. Type I wire rope will be capable of operation within a -65 °F to +250 °F (-54 °C to +121 °C) temperature range in wind, dust, fuel, and oil spills, in wash-down and other environmental stresses and aircraft experiences. Type II wire rope will be capable of operation within a -65 °F to +200 °F (-54 °C to +94 °C) temperature range in wind, dust, fuel, and oil spills, in wash-down and other environmental stresses and aircraft experiences.

1.2 <u>Classification</u>. The wire rope will be of the following types and compositions, as specified (see 6.2).

1.2.1 <u>Types</u>. The types of wire rope are as follows:

Type I - Nonjacketed wire rope Type II - Jacketed wire rope

1.2.2 <u>Compositions</u>. The compositions of the wire rope are as follows:

Composition A - Carbon steel, zinc, or tin over zinc coated Composition B - Corrosion resistant steel

2.4 <u>Order of precedence</u>. Unless otherwise noted herein or in the contract, in the event of a conflict between the text of this document and the references cited herein (except for related specification sheets), the text of this document takes precedence. Nothing in this document, however, supersedes applicable laws and regulations unless a specific exemption has been obtained.

3. REQUIREMENTS

3.1 <u>Specification sheets</u>. The individual item requirements shall be as specified herein and in accordance with the applicable specification sheet. In the event of any conflict between the requirements of this specification and the specification sheet, the latter shall govern.

3.2 <u>Qualification</u>. Wire rope (see 6.4.16) furnished under this specification shall be products that are qualified for listing on the applicable qualified products list at the time of award of contract (see 4.2 and 6.3). Products must be qualified by a test facility located in the continental United States or Canada (see 4.1). The qualifying activity will be advised of any plant relocation, changes in key personnel, or major process change(s) (e.g. changes in lubricant and/or jacketing material, changes in the lubricant application process, etc.) for requalification testing determinations.

3.2.1 <u>Wire rope for type II</u>. The wire rope that is to be nylon jacketed to form type II must be qualified as type I, composition A or B, wire rope in accordance with the provisions of this specification. Upon type I wire rope being subjected to subsequent processing for qualification or manufacture as a type II wire rope, it shall not be certified or shipped as a type I wire rope. Type II wire rope shall not be remanufactured into type I wire rope.

3.3 Materials and protective coating.

3.3.1 <u>Steel for composition A</u>. High carbon steel in accordance with SAE AIR4127 shall be used for composition A wire rope and shall be of one type. The carbon steel shall be capable of meeting the requirements of this specification.

3.3.2 <u>Steel for composition B</u>. Corrosion resistant steel S30200 or S30400 in accordance with SAE HS-1086 shall be used for composition B, type I and II, wire rope.

3.3.3 <u>Protective coating</u>. Composition A wires shall be thoroughly and uniformly coated by the methods specified in 3.3.3.1 or 3.3.3.2 (see 6.2).

3.3.3.1 <u>Zinc coating for composition A</u>. Zinc coating of composition A wires shall be by the hot dipped or electroplated process and shall conform to the following:

3.3.3.2 <u>Tin coating for composition A</u>. Tin coating over zinc of composition A wires shall be by the hot-dipped or electroplated process and shall conform to the following:

3.3.3.3 <u>Nylon jacketed coating for type II</u>. The nylon jacketing (see 6.4.2) material shall meet the requirements of this specification as specified in 3.3.3.3.1 and shall be extruded over the rope. Only virgin nylon material shall be used in coating on type II wire rope.

3.3.3.1 <u>Nylon jacketing physical and mechanical properties</u>. The nylon used to jacket the wire rope shall be tested in accordance with 4.5 and meet the requirements listed below when tested as specified in the following paragraphs:

3.3.4 <u>Lubricant</u>. Each wire of the wire rope shall be coated with a friction-preventive, non-corrosive lubricant. As a minimum, the lubricant shall operate at temperatures from -65 °F to +250 °F (-54 °C to +121 °C). Any change in lubricant is considered a major process change and may require requalification testing (see 3.2).

3.4 Construction.

3.4.1 <u>Wire</u>. The wire (see 6.4.15) used in steel wire rope cable shall be cylindrical, smooth, and of uniformly high quality.

3.4.1.1 <u>Wire properties</u>. Tensile strengths of wire and wire sizes shall be such that wire rope will be capable of meeting the requirements of this specification.

3.4.1.2 <u>Preforming (see 6.4.9) of wires and strands</u>. The individual wires and strands composing the wire rope shall be shaped into the exact helical position they will have in the finished wire rope, so that if the wire rope is cut or severed there is no tendency for the measured diameter of the wire rope at the unseized cut ends to increase by more than the amount specified in table I.

3.4.1.3 <u>Splicing and joining</u>. All splices or joints in wires less than 0.008 inch may be longitudinally twisted. All wire sizes of 0.008 inch or more shall be brazed or welded. Any joints in individual wires in any layer of a strand (see 6.4.12) shall not be closer than 20 feet except as specified in 3.4.1.3.1 (see 4.5.2).

3.4.1.3.1 <u>Twist-off</u>. When a twist-off (see 6.4.14) occurs during fabrication of the 7-wire layer of a 19-wire strand (see 3.4.1.3), splices and joints in individual wires may be as close as 18 inches.

3.4.2 <u>Wire rope lengths</u>. The wire rope shall be furnished on reels in lengths specified by the procuring activity. There will be no more than two pieces of wire rope on the reel. The shortest piece shall be a minimum of 20 percent of the reel length. The distance to the break point on the reel shall be marked on the reel and package (see 3.6.3).

3.4.3 <u>Wire rope construction</u>. Flexible steel wire rope shall be 3×7 , 7×7 , or 7×19 construction and shall be regular lay (see 6.4.10) for the respective diameters, the dimensional tolerances, and the physical properties as specified in tables I and II.

3.4.3.1 <u>Construction 3 x 7</u>. Wire rope of this construction shall consist of 3 strands of 7 wires each laid together without a core. Each strand shall consist of a layer of 6 wires laid around a center wire (see 6.4.1) in a left-hand direction. The 3 strands shall be laid together in a right-hand direction. The length of lay (see 6.4.3 and 6.4.4) of the 6 outer wires in each strand shall not exceed 70 percent of the lay of the finished rope. The length of lay of the finished wire rope shall not be more than 7 nor less than 5 times the nominal wire rope diameter (see 6.4.17).

3.4.3.2 <u>Construction 7 x 7</u>. Wire rope of this construction shall consist of 6 outer strands of 7 wires each laid around a strand core (see 6.4.13) of 7 wires. The 6 outer strands shall consist of a layer of 6 wires laid around a center wire in a left-hand direction. The strand core shall consist of a layer of 6 wires laid around a center wire in a right-hand direction. The 6 outer strands shall be laid around the core in a right-hand direction. The length of lay of the outside 6 wires in each of the 6 outside strands and the outside 6 wires of the strand core shall not exceed

60 percent of the lay of the finished wire rope. The length of the lay of the finished wire rope shall be not more than 8 nor less than 6 times the nominal rope diameter.

3.4.3.3 <u>Construction 7 x 19</u>. Wire rope of this construction shall consist of 6 outer strands of 19 wires each laid around a strand core of 19 wires. The 6 outer strands shall each consist of a layer of 6 wires laid around a center wire in a left-hand direction and a layer of 12 wires laid over the 7-wire strand in a left-hand direction. The strand core shall consist of a layer of 6 wires laid around a center wire in a right-hand direction and a layer of 12 wires laid around the 7-wire strand in the right-hand direction. The 6 outer strands shall be laid around the core in a right-hand direction. The length of lay of the inside layer of 6 wires in each of the 6 outer strands and the one strand core shall not exceed 60 percent of the outside layer of 12 wires in each of the 6 outer strands and the strand core shall not exceed 50 percent of the lay of the finished wire rope. The length of the lay of the lay of the finished wire rope shall not be more than 8 nor less than 6 times the nominal rope diameter.

3.5 Performance.

3.5.1 <u>Operating range</u>. The wire rope shall be capable of operation in wind, dust, fuel, oil spills, wash-down, and other aircraft environmental stresses and experiences at the temperature ranges specified in paragraphs 3.5.1.1 and 3.5.1.2.

3.5.1.1 <u>Type I</u>. Type I wire rope shall be capable of operating within a -65 °F to +250 °F (-54 °C to +121 °C) temperature range.

3.5.1.2 <u>Type II</u>. Type II wire shall be capable of operating within a -65 °F to +200 °F (-54 °C to +94 °C) temperature range.

3.5.2 <u>Wire flexibility</u>.

3.5.2.1 <u>Ductility of steel</u>. Composition A or B wire shall not fracture when wrapped in accordance with 4.4.1.1 prior to wire rope fabrication.

3.5.2.2 <u>Adherence of coating</u>. The tin or zinc coating shall not crack or flake when wrapped in accordance with 4.4.1.2 prior to wire rope fabrication. Loosening or detachment of small superficial particles of coating (formed by mechanical polishing of the surface) during the adhesion test is acceptable.

3.5.3 <u>Breaking strength</u>. The type I, composition A and B, wire ropes shall have the minimum breaking strength (MBS) (see 6.4.7) as shown in table I.

3.5.4 <u>Endurance, type I wire rope</u>. Each wire rope size of each construction shall be capable of withstanding the respective tension loads, reversals, and breaking strength shown in table III.

3.5.5 <u>Endurance, type II wire rope</u>. Each wire rope size of each construction shall be capable of withstanding the respective tension loads, reversals, and breaking strength shown in table IV. There shall be no cracking or deterioration of the nylon coating after the test.

3.5.6 <u>Stretch limits</u>. The stretch in each wire rope size of each construction shall not exceed 1.5 percent when it is loaded to 60 percent of the MBS as shown in table I.

3.5.7 <u>Test load</u>. Each wire rope size of each construction shall carry 80 percent of its respective MBS load, as shown in table I, without any failures of the individual wires in the rope.

3.5.8 <u>Jacket characteristics, type II</u>. The nylon jacketed wire rope shall have characteristics in accordance with the requirements of table II.

3.5.9 <u>Low temperature flexibility, type II</u>. Each size of each type II jacketed rope shall be bent or flexed at a temperature of -65 °F (-54 °C) without any deleterious effects such as cracking of the nylon or separation from the wire rope.

3.5.10 <u>Resistance to fluids</u>. Type II wire rope shall show no deleterious effects when immersed in the fluids listed in 4.4.10.

3.6 <u>Identification of product</u>. The wire rope shall be identified in accordance with the following:

3.6.1 <u>Identification by number</u>. Each manufacturer shall assign a significant identification number on each manufacturing reel of wire rope. When the wire rope on the manufacturing reel is cut to specified lengths for transfer to the shipping reel (see 6.4.11), each shipping reel shall be marked with the identification number of the manufacturing reel.

3.6.2 <u>Identification by color tracer filament</u>. Each manufacturer shall identify every wire rope by the use of color filaments manufactured into the rope. The specification preparing activity will assign a combination of colors to each manufacturer desiring qualification. The inclusion of color tracing filaments alone does not designate that the wire rope is in full conformance with this specification or has met qualification requirements, but only serves to identify the manufacturer. Color tracer filaments are not mandatory in 3 x 7 construction.

3.6.3 <u>Identification of reels and shipping containers</u>. Each shipping reel and shipping container shall be marked in accordance with the requirements of MIL-STD-129. The following information shall be included:

a. Stock No. or identification as specified in the contract. $\underline{1}/$

b. Size (include diameter of wire rope, outside diameter of nylon).

- c. Name of wire rope manufacturer.
- d. Name of contractor.
- e. Contractor order number.

f. Type of wire rope, composition, protective coating for composition A, and specification number (MIL-DTL-83420).

g. Date of manufacture (month/year).

h. For reels with 2 lengths of wire rope, record distance from outside end to separation point and total length of wire rope on the reel.

i. Manufacturing reel/lot number.

1/ The contractor shall enter the National Stock Number (NSN) specified in the contract or as furnished by the procuring activity. Space shall be left for the NSN when not available.

3.7 <u>Workmanship and finish</u>. All details of workmanship and finish shall be in accordance with the best practice for high quality aircraft wire rope consistent with the requirements of this specification. The finished cable shall be uniform in construction and securely laid, free from kinks, loose wires, loose strands, or other defects (see 4.4.2). Protruding wires are considered a defect and not more than one broken wire will be accepted in 1000 feet of wire rope.

3.7.1 <u>Physical appearance, type II</u>. The nylon jacket shall be uniform in outside diameter (O.D.) and in wall thickness as specified in table II and shall be uniform in appearance. The nylon jacket shall be translucent and shall be homogeneous and uniform in consistency. The jacketed wire rope shall have no cracks or seams, or foreign material in the nylon on the surface. Any deleterious effects, such as cracking or separating from the wire rope, shall be cause for rejection.

3.7.1.1 <u>Concentricity</u>. The differences in wall thickness as determined in 4.4.2.1 shall not exceed 20 percent.

4. VERIFICATION

4.1 <u>Classification of inspection</u>. The inspection and testing of the wire rope shall be classified as follows:

a. Qualification inspection (see 4.2).

b. Conformance inspection (see 4.3).

4.2 Qualification inspection.

4.2.1 <u>Qualification inspection samples</u>. When conducting qualification tests specified herein, one sample lot for each size and construction of wire rope listed in tables I and II, for which qualification is desired, shall be taken after any discard has been removed from the head or starting end of the first manufacturing reel for each lot of wire rope.

4.2.1.1 <u>Lot</u>. A qualification inspection lot shall consist of 50 feet of wire rope of the same construction and diameter produced continuously by one machine or by one series of progressive processing machines.

4.2.2 <u>Qualification testing</u>. Qualification tests shall be performed for each size and construction of wire rope for which qualification is desired as specified in table V.

4.2.3 <u>Qualification for type II</u>. Qualification for type II wire rope shall be finalized after the following:

a. Receipt from the nylon manufacturer of a test report that includes, as a minimum, the results of the tests specified in 4.5.

b. Successful completion of the remaining qualification tests for type II wire rope.

4.2.3.1 <u>Duplication nylon certification</u>. If two or more type II wire rope sizes are submitted for qualification, and the nylon coating is of the same type and grade, copies of the original test certification on the particular type and grade of nylon will satisfy the requirement as specified in 4.2.3 and 4.3.4.

4.2.4 <u>Maintenance of qualification</u>. At specified intervals determined by the qualifying activity, the manufacturer must be able to demonstrate that the company still has the capabilities and facilities necessary to produce the QPL items in accordance with this specification and in accordance with the provisions governing qualification specified in SD-6.

4.3 <u>Conformance inspection</u>. Conformance inspection shall consist of individual tests and sampling tests.

4.3.1 <u>Individual tests</u>. Each size wire rope of each type, composition, and construction furnished under each contract or order shall be subject to the following tests as described under 4.4 (see table V):

- a. Ductility of steel (4.4.1.1).
- b. Adherence of coating (4.4.1.2).
- c. Examination of product (4.4.2).
- d. Concentricity tests for type II wire rope (4.4.2.1).
- e. Conformance test to preforming of cable (4.4.2.2).
- f. Color-coding identification (4.4.11).

4.3.2 Sampling plan.

4.3.2.1 Sample.

4.3.2.1.1 <u>Wire rope</u>. When conducting the sampling tests specified herein, one continuous sample of sufficient length shall be taken after any discard has been removed from the head or starting end of the first manufacturing reel for each lot of wire rope.

4.3.2.1.2 <u>Wire</u>. When conducting the sampling tests specified herein, one random sample of wire, of sufficient length to meet testing requirements, shall be taken from the wire lot.

4.3.2.2 <u>Lot</u>.

4.3.2.2.1 <u>Wire rope</u>. A lot shall consist of not more than 20,000 feet of wire rope of the same construction and diameter produced continuously by one machine or by one series of progressive processing machines.

4.3.2.2.2 <u>Wire</u>. A lot shall consist of wire of one size produced from the same heat of steel in one continuous process.

4.3.2.3 <u>Specimen</u>. A specimen is a section of wire rope or wire cut from a sample for the performance of a testing method. All specimens shall be taken from the lot furnished under that specific order.

4.3.3 <u>Sampling tests</u>. The conformance sampling tests shall be performed in accordance with the paragraphs listed in table V.

4.3.4 <u>Certification</u>. For each contract or order, the wire rope manufacturer shall certify that the product satisfactorily passed the conformance inspections (see 4.3.1 and 4.3.3) of this specification. The certification shall include, as a minimum, actual results of the tests specified herein and shall be retained on file at the manufacturer's facility for a minimum of 7 years.

4.3.5 <u>Nylon certification</u>. For each contract or order, a certification from the nylon manufacturer shall verify that the nylon meets the requirements of this specification (3.3.3.3 and 3.3.3.3.1) (see 6.3). The certification will be retained on file at the manufacturer's facility for a minimum of 7 years.

4.4 Test methods.


4.4.1 <u>Wire flexibility</u>.


4.4.1.1 <u>Ductility of steel</u>. A specimen from the wire sample shall be wrapped in a way that does not cause indenting. The wire shall be wrapped around a cylindrical mandrel for 2 complete turns in a close helix at a rate not exceeding 15 turns per minute. The cylindrical mandrel diameter shall be equal to the nominal wire diameter being tested for composition B, and two times the nominal diameter being tested for composition A.

4.4.1.2 <u>Adherence of coating</u>. A specimen from the tin or zinc coated wire sample shall be capable of being wrapped at a rate not to exceed 15 turns per minute in close helix of at least 2 turns around a cylindrical mandrel equal to 2 times the nominal diameter of the wire under tests without cracking or flaking the tin or zinc coating to such an extent that any tin or zinc can be removed by rubbing with the bare finger.

4.4.2 <u>Examination of product</u>. Each sample of wire rope shall be visually examined for workmanship and finish to determine compliance with 3.7.

4.4.2.1 <u>Concentricity test for type II wire rope</u>. All type II wire rope shall be examined for concentricity as specified in 3.7.1.1. The wall thickness shall be measured 180 degrees apart in two 90 degrees planes. The percent variation in wall thickness shall be calculated as follows:





This calculation shall be repeated for dimensions A and B.

4.4.2.2 <u>Conformance test to preforming of wire rope</u>. To test wire rope for conformity to values shown in table I for increase in diameter, the wire rope shall be mechanically cut with a cutter having constricting jaws. A plain shear with straight blades distorts the product and may void the test. After cutting, the wire rope shall be measured by passing the wire rope through a hole drilled to a diameter increased as shown in table I under "Allowable increase in diameter at cut end" or by using a shadowgraph with suitable magnification. The allowable increase in diameter shall be applied to the actual diameter of the wire rope being tested.

4.4.3 <u>Breaking strength type I, composition A and B</u>. A specimen for each size and construction of wire rope shall be selected from the sample from each lot. The specimen shall be no less than 24 inches in length, and where necessary, swaged terminals conforming to MIL-DTL-781 (do not use ball end fittings) and accompanying hardware may be used to facilitate installation of the specimen in the jaws of the testing machine. The length of wire rope sample under load shall be no less than 10 inches. The breaking strength shall be determined by use of a tensile testing machine in accordance with applicable requirements of ASTM E8/E8M. The breaking strength shall conform to the requirement of table I. In case of failure due to an unsatisfactory end termination, the test will be disregarded and a new test conducted.

4.4.4 <u>Endurance testing for type I</u>. The test set-up for the endurance tests for all type I wire rope shall conform to figure 1. The total travel of the wire rope in one direction shall be 13.5 inches. The test sheaves shall be made of steel and shall conform to the dimensions of figure 2 and the individual wire diameters in table VI. The application of lubricant to the endurance test sample, in addition to the lubricant applied during the manufacture of wire rope, shall not be permitted either before or during the endurance test.

4.4.4.1 <u>Endurance testing at -65°F (-54°C) for type I, composition A</u>. An endurance test at -65°F (-54°C) shall be conducted for each type I, composition A, wire rope diameter and construction specified in 4.4.4. The number of reversals and tension loads shall be as indicated in table III. After the endurance test at -65°F (-54°C), a test specimen that is that portion of the

wire rope that passes over the test sheave during the endurance test shall be selected for breaking strength tests. From this specimen, two samples representing the top and bottom sheave of the specimen shall be subjected to a breaking strength determination as specified in 4.4.3, except the breaking strength of each sample shall be equal to or greater than that specified in table III.

4.4.4.2 Endurance test at room temperature for type I, composition A and B. An endurance test at room temperature shall be conducted for each type I, composition A and B, wire rope diameter and construction as specified in table III. The number of reversals and tension loads shall be as indicated in table III. After the endurance test at room temperature, a test specimen that is that portion of the wire rope that passes over the test sheave during the endurance test shall be selected for breaking strength tests. From this specimen, two samples representing the top and bottom sheave of the specimen shall be subjected to a breaking strength determination as specified in 4.4.3, except the breaking strength of each sample shall be equal to or greater than that specified in table III.

4.4.5 <u>Endurance testing for type II</u>. The test set-up for the endurance tests of type II nylon jacketed wire rope shall conform to figure 1. The total travel of the wire rope in one direction shall be 13.5 inches. The test sheaves shall be made of steel and shall conform to the dimensions of figure 2 and the individual wire diameters in table VII which conform to the O.D. size of the nylon coating, and test loads which conform to the wire rope size.

4.4.5.1 Endurance testing at -65°F (-54°C) for type II, composition A and B. An endurance test at -65°F (-54°C) shall be conducted for each type II, composition A and B, wire rope diameter and construction specified in table IV. The number of reversals and tension loads shall be as indicated in table IV. After the endurance test at -65°F (-54°C), a test specimen that is that portion of the nylon jacketed wire rope that passes over the test sheave during the endurance test shall be selected for breaking strength tests. From this specimen, two samples representing the top and bottom sheave of the specimen shall be subjected to a breaking strength determination as specified in 4.4.5, except the breaking strength of each sample shall be equal to or greater than that specified in table IV.

4.4.5.2 Endurance test at room temperature for type II, composition A and B. An endurance test at room temperature shall be conducted for each type II, composition A and B, wire rope diameter and construction as specified in table IV. The number of reversals and tension loads shall be as indicated in table IV. After the endurance test at room temperature, a test specimen that is that portion of the nylon jacketed wire rope that passes over the test sheave during the endurance test shall be selected for breaking strength tests. From this specimen, two samples representing the top and bottom sheave of the specimen shall be subjected to a breaking strength determination as specified in table IV, except the breaking strength of each sample shall be equal to or greater than that specified in table IV.

4.4.6 <u>Stretch test for type I, composition A and B</u>. One specimen from each sample of wire rope selected as specified in 4.4.3 shall be tested to determine the percent stretch. The total length of the wire rope specimen to be tested shall not be less than 24 inches. Where necessary, swaged terminals and accompanying hardware may be used to facilitate installation of the specimen in the jaws of the test machine. The amount of stretch shall be determined on a tension

testing machine in accordance with ASTM E8/E8M. The specimen shall be loaded to one percent MBS shown in table I to straighten the wire rope and, while the specimen is under tension, a gauge length not less than 10 inches shall be marked on the wire rope between the end fittings of the testing specimen. The specimen shall then be loaded to 60 percent of MBS and measured for elongation under load. From these data, the percent stretch can be calculated using the formula below:

Elongation of gauge length under load Percent stretch = ------ x 100 \leq 1.5% Original gauge length

4.4.7 <u>Test load for type I, composition A and B</u>. The following test shall be conducted using the same wire rope specimen used in stretch test, or similarly prepared specimen. Load the specimen to one percent of breaking strength and then increase the loading to 80 percent of the minimum required breaking strength of the wire rope specified in table I. The load shall be applied for five seconds. At the end of the test, the entire wire rope shall be completely unwound and every wire inspected. A suitable electronic device capable of detecting the breaking of individual wires during testing may be used instead of unwinding the wire rope. The failure of any wire shall be cause for rejection (see 4.4.7.1).

4.4.7.1 <u>Use of acoustic, electronic device for first wire break test</u>. The load shall be increased to 80 percent on the test specimen. If no ping (see 6.4.8) is heard, the specimen has passed the test. If one or more pings are heard, the wire rope specimen shall be unraveled and the broken wires shall confirm failure of the specimen. If no broken wires are found, the specimen has passed the test.

4.4.8 Protective coating.

4.4.8.1 Tin or zinc coating, composition A.

4.4.8.1.1 <u>Preparation of specimens</u>. For qualification, three specimens not less than 12 inches long shall be cut from the wire before the wire rope is fabricated. These specimens shall be cut from each size of wire to be used in making each lot of wire rope. Optionally, three 12-inch samples of the wire rope may be cut off and used for specimens.

4.4.8.1.2 <u>Tin-coated wire</u>. The weight of tin coating on samples of tin-coated wire shall be determined by first selecting a sample of the coating, weighing the sample, establishing the percentage of tin present through the use of atomic absorption, and then multiplying the sample weight by the percent of tin present (as determined by the atomic absorption).

4.4.8.1.3 <u>Zinc-coated wire</u>. The weight of coating on samples of zinc-coated wire shall be determined in accordance with ASTM A90/A90M.

4.4.9 Low temperature flexibility for type II, composition A and B. The jacketed wire rope for qualification testing shall be subjected to -65 °F (-54 °C) for a period of 24 hours in a straight position. After this time and while still at the specified temperature, the sample shall be

evenly and uniformly bent over a test sheave with the same dimensions as the endurance sheave for the particular size wire rope. Bending shall be accomplished in a period of not less than 8 seconds and not more than 12 seconds, and the wire rope shall be bent at least 180 degrees in the groove of the sheave. After flexing, straighten the wire rope out and allow to warm to room temperature in four to six hours, then examine the flexed area under a magnification of 20 x power. There shall be no evidence of cracks or separation of the nylon jacket from the wire rope.

4.4.10 <u>Resistance to fluids on type II, composition A and B</u>. For qualification testing, totally immerse a separate 3-inch unsealed length of nylon jacketed wire rope in each of the fluids listed below for four hours. Remove, wipe dry, and record appearance of each one of the specimens. Deleterious effects such as softening, cracking, or separation shall be cause for rejection. A separate test specimen shall be used for each fluid test.

a. MIL-PRF-5606 Hydraulic fluid
b. MIL-DTL-5624 Jet fuel JP-4 and JP-5
c. MIL-PRF-7808 Lubrication oil
d. SAE AMS 1424 Deicing/Anti-icing fluid
e. MIL-H-19457 Hydraulic fluid (skydrol 500A, or equivalent)
f. MIL-PRF-87937 Cleaning compound
g. MIL-PRF-83282 Hydraulic fluid
h. ASTM D910 Aviation gasolines

4.4.11 <u>Color-coding identification</u>. Each wire rope sample shall be inspected for proper identification as specified in 3.6.2.

4.5 <u>Nylon testing for type II</u>. The nylon manufacturer shall perform all the tests specified herein to determine compliance with the requirements of 3.3.3.3 herein. The test specimen shall be molded into a shape needed to perform the tests. The nylon jacket extrusion material lot number shall be identified in the molding test report.

4.5.1 <u>Tensile strength, percent elongation</u>. Specimens shall be molded into type 4 test bars and tests shall be conducted in accordance with ASTM D638.

4.5.2 <u>Specify gravity</u>. Specimens shall be molded and tests shall be conducted in accordance with ASTM D792.

4.5.3 <u>Water absorption</u>. Specimens shall be molded and tests shall be conducted in accordance with ASTM D570.

4.5.4 <u>Brittleness</u>. Specimens shall be molded and tests shall be conducted in accordance with ASTM D746.

4.5.5 <u>Stiffness</u>. Specimens shall be molded and tests shall be conducted in accordance with ASTM D790.

4.5.6 <u>Heat deflection</u>. Specimens shall be molded and tests shall be conducted in accordance with ASTM D648.

4.5.7 <u>Melting range</u>. Specimens shall be molded and tests shall be conducted in accordance with ASTM D3418.

4.5.8 <u>Burn resistance</u>. Specimens shall be molded and tests shall be conducted in accordance with ASTM D635.

4.6 <u>Preparation for delivery</u>. The preservation, packaging, packing, and marking shall be examined for conformance to section 5.

5. PACKAGING

5.1 <u>Packaging</u>. For acquisition purposes, the packaging requirements shall be as specified in the contract or order (see 6.2). When packaging of material is to be performed by DoD or in-house contractor personnel, these personnel need to contact the responsible packaging activity to ascertain packaging requirements. Packaging requirements are maintained by the Inventory Control Point's packaging activities within the Military Service or Defense Agency, or within the military service's system commands. Packaging data retrieval is available from the managing Military Department's or Defense Agency's automated packaging files, CD-ROM products, or by contacting the responsible packaging activity.

6. NOTES

(This section contains information of a general or explanatory nature that may be helpful, but is not mandatory.)

6.1 <u>Intended use</u>. The wire rope covered by this specification is intended for use in aircraft flight control systems applications where high resistance is needed against corrosion, abrasion, and fatigue wear.

6.2 <u>Acquisition requirements</u>. Acquisition documents should specify the following:

- a. Title, number, and date of the specification.
- b. Type and composition of wire rope (see 1.2).
- c. Size and construction of wire rope (see specification sheet).
- d. For type II, also specify jacket outside diameter.
- e. For composition A, specify type of protective coating (see 3.3.3).
- f. Length of wire rope per reel to be furnished.
- g. Packaging requirements (see 5.1).

6.3 <u>Qualification</u>. With respect to products requiring qualification, awards will be made only for products that are, at the time of award of contract, qualified for inclusion in QPL-83420 whether or not such products have actually been so listed by that date. The attention of contractors is called to these requirements, and manufacturers are urged to arrange to have the products that they propose to offer to the Federal Government tested for qualification in order that they may be eligible to be awarded contracts or orders for the products covered by this specification. Information pertaining to qualification of products may be obtained from Defense Logistics Agency Aviation VEB, 8000 Jefferson Davis Highway, Richmond, VA 23297-5616 or STDZNMGT@dla.mil.

6.4 Definitions.

6.4.1 <u>Center wire</u>. The center of all strands is an individual wire and is designated as a center wire.

6.4.2 <u>Jacketing</u>. Jacketing is the sheet or shielding coating around the wire rope and is extruded over the wire rope to completely enclose the wire rope with a protective coating.

6.4.3 <u>Lay (twist)</u>. The helical form taken by the wires in the strand and by the strand in the wire rope is characterized as the lay (twist) of the strands or wire rope, respectively. In a right-hand lay, the wires of strands are the same direction as the thread on a right-hand screw, and for a left-hand lay, the strands or wires lay in an opposite direction.

6.4.4 <u>Length of lay (pitch)</u>. The distance parallel to the axis of the strand or cable, in which a wire or strand makes one complete turn about the axis, is designated as the length of lay (pitch) of the strand or wire rope.

6.4.5 <u>Lubricant leak-out</u>. Lubricant leak-out (see 3.3.4) and evaporation of the lubricant applied to the wire rope during fabrication and preparation of shipment can be expected. In order to ensure optimum performance with wire rope manufactured to this specification, the user should relubricate the wire rope upon installation and periodically throughout its service life. The method of lubrication, frequency, and identity of the approved military standard lubricant should be included in the appropriate aircraft maintenance manuals.

6.4.6 <u>Master reel</u>. The master reel is the large manufacturing reel that is used to hold the wire rope as it is continuously manufactured.

6.4.7 <u>Minimum breaking strength</u>. The minimum tension load that a wire rope must support.

6.4.8 <u>Ping</u>. Ping is an audible sound given off as a result of an individual wire breaking in the wire rope. The sound is amplified and fed into a speaker system to a level distinctly detectable by the human ear.

6.4.9 <u>Preforming</u>. Wire and strand shaped, during fabrication of the wire rope, to conform to the form or curvature which they take in the finished wire rope.

6.4.10 <u>Regular lay</u>. Wire rope in which the direction of the lay of the wires in the strand is in an opposite direction to the lay of the strand in the wire rope.

6.4.11 <u>Shipping reel</u>. The shipping reels are cut from the master reel (see 6.4.6) as needed.

6.4.12 Strand. Each group of wires helically twisted is designated as a strand.

6.4.13 <u>Strand core</u>. A strand core consists of a single straight strand made of wires similar to the other strands comprising the cable in arrangement and number of wires.

6.4.14 <u>Twist-off</u>. Twist-off is a twisting severance of the strand or wire due to a malfunctioning of the stranding equipment.

6.4.15 <u>Wire</u>. Each individual cylindrical element is designated as a wire.

6.4.16 <u>Wire rope</u>. A group of 3 or more strands helically twisted is designated as a wire rope.

6.4.17 <u>Wire rope diameter</u>. The diameter of wire rope is the diameter of the circumscribing circle, or the distance across opposite strands.

6.5 Subject term (key word) listing.

6.6 <u>Supersession data</u>. This specification supersedes MIL-W-1511, MIL-W-5424, MIL-W-83343, and MIL-W-83420.

6.7 <u>Amendment notations</u>. The margins of this specification are marked with vertical lines to indicate modifications generated by this amendment. This was done as a convenience only and the Government assumes no liability whatsoever for any inaccuracies in these notations. Bidders and contractors are cautioned to evaluate the requirements of this document based on the entire content irrespective of the marginal notations.




